AND NOW, this 25<sup>th</sup> day of August, 2023, upon consideration  
of Plaintiffs' Motion for Preliminary Injunction, it is hereby ORDERED, ADJUDGED, and  
DECREED that the Motion be, and the same hereby, is GRANTED, and a PRELIMINARY  
INJUNCTION is hereby ENTERED and Defendants, CITY OF DUBOIS, EDWARD  
WALSH, in his capacity as mayor and president of council; DIANE BERNARDO, in her  
capacity as vice president of council; JAMES AUGHENBAUGH, in his capacity as  
councilman; SHANE DIETZ, in his capacity as councilman; and the CITY COUNCIL  
BOARD FOR THE CITY OF DUBOIS, and any other person or entity acting in concert or  
participation with said Defendants, is hereby enjoined from and ordered as follows:

A. that the Defendants will refrain from making any additional payments to City  
Manager John "Herm" Suplizio through the end of the existing term.

B. to refrain from making any "Pension" distributions, including, but not limited to, distribution of the City Manager's contribution to the pension fund pending further Order of Court. Further, the City shall refrain from entering into any new contract or binding agreement with the City Manager pending further Order of Court.


